**WAKESHMA TOWNSHIP, KALAMAZOO COUNTY
RESOLUTION TO AUTHORIZE 2018 MILLAGE LEVY**

WHEREAS, the Township Board of Wakeshma Township is required to hold a public hearing in order to approve a levy of additional millage rates for the 2018-2019 fiscal year, in accordance with the General Property Tax Act, Public Act 206 of 1893, as amended, specifically MCL 211.24e, otherwise known as a "Truth in Taxation Hearing", and

WHEREAS, the Township proposes to raise its levied millage rate by an additional 3.0 mills, as approved by the Township voters at an election on November 6, 2018, and

WHEREAS, the Township Board of Wakeshma Township intends to levy these additional mills for Township road operations (local road repairs, upgrades, construction, improvement and maintenance purposes) on the December 2018 tax bill; and

WHEREAS, notice of the hearing to consider the millage levy as required was accurately published and posted, indicating that on November 28, 2018, the Township Board would hold a meeting to approve a millage levy,

NOW THEREFORE BE IT HEREBY RESOLVED as follows:

1. That the Township Board of Wakeshma Township held a Truth in Taxation hearing, pursuant to MCL 211.24e, on November 28, 2018 at 6:00 pm in the Wakeshma Township Hall.
2. That the hearing is regarding the approval of the levy of an additional 3.0 mills for the purposes of township road operations, including local road repair, upgrades, construction, improvement and maintenance purposes.
3. The taxes collected from the millage in December 2018 will be used in the funding of road repairs, construction, upgrades, improvement and maintenance purposes as specified in the millage request in the 2018- 2019 fiscal year.

4. The authorized millage rates were properly noticed and are attached hereto.
